In a 6-man football game played at Cheylin on Friday, Oct. 2, the Tribune Jackrabbits lost to the Cheylin Cougars 55-5.
The Cougars jumped out with two quick scores in the first quarter on a pass and a 6-yard run to lead 13-0.
The Jackrabbits scored

on a 19-yard pass from Jacob Miller to Jariath Yanez. The PAT attempt failed and Tribune trailed 6-13.
The Cougars scored two more touchdowns in the second quarter on an 11-yard pass and a 46-yard td run to lead 27-6 at the end
